The Conference will be held at the Royal Sonesta Hotel located at 300 Bourbon Street, New Orleans, Louisiana. The Association represents over 300 local, state, and federal agents involved in all aspects of drug enforcement and police work.

Seminars and conferences of this type are often the only opportunity many of these officers have to see the latest technology, supplies and weapons used in drug enforcement police work. After returning to their respective departments, they are then able to recommend, purchase and use your products and services. These special room rates are being offered 3 days prior, during and 3 days after the conference dates based on the Hotel's availability prior to the cut-off date. Reservations can be made by calling the Royal Sonesta (504-586-0300) and stating that you will be attending the LNOA Conference. You can also book your reservation at the Royal Sonesta through the link on the LNOA website (LNOA.net), which is usually a quicker and more accurate way to register. The cut-off date for reservations is July 14, 2026. A \$30.00 per car per night parking fee has also been negotiated for LNOA.
